## 5. Laois Local Economic & Community Plan 2016-2021:

Ms. Georgina Ireland advised the meeting that it is intended to carry out a composite review of the LECP in 2018. The LECP Advisory Steering Group will reconvene to decide how best to review the LECP and feed back to stakeholders. Mr. John Mulholland stated that we are two and a half years on since the LECP document first issued; much has been achieved to date e.g. the LEO, Business Support Unit, Tourism Board, employment rates. Upon the proposal of Mr. Michael Bergin and seconded by Mr. Joe Thompson, it was agreed that such a review should be carried out in conjunction with the Councils Economic, Enterprise and Planning SPC.

### 6. Healthy Ireland Update

The Members were advised that the sub-committee met to consider the draft Healthy Laois Strategy prepared by Exodea Consulting. It is intended that the final draft strategy be presented to June LCDC meeting for approval. An update on the 9 Healthy Ireland Actions was provided by Ms. Louise McEvoy. Mr. John Mulholland commented on the many achievements to date under the Healthy Ireland fund with many diverse projects receiving grants. Members were informed that Round 2 of the Fund is now open for applications with a closing date of 11<sup>th</sup> May 2018.
