have to go through this, as they grow up," he said.

Mr Nevin would not give a date when the protest would take place. He said he would be taking the issue up with Pavee Point, the representative group for Irish Travellers.

He said he would go to court to object to licences being renewed by pubs when the applications come before Portlaoise District Court.

The Laois branch of the Irish Vintners Association declined to comment.

Meanwhile, two Traveller familes were left homeless last week after their homes were destroyed by fire. night /Wednesday night.

"My two sons were burned out, everything that they had is gone and they not have a penny to their names to replace anything," said Mrs McDonagh.

"She said one of her sons has three infant children but had just left the house.

"The two children of her other son were staying elsewhere."
