71. APPROVAL OF ELECTED COUNCIL TO THE RAISING OF A LOAN NOT EXCEEDING €13,000,000 FROM THE HOUSING FINANCE AGENCY PLC.

On the proposal of Councillor Tom Jacob, seconded by Councillor James Deegan, the Members unanimously agreed to the raising of a loan not exceeding €13,000,000 from the Housing Finance Agency Plc. in respect of the issuing of mortgage finance under the Affordable Housing and Shared Ownership Schemes.

72. APPROVAL OF ELECTED COUNCIL TO OVERDRAFT ACCOMMODATION IN THE SUM OF €6,000,000. FOR THE HALF YEAR ENDED 31ST DECEMBER 2006.

On the proposal of Councillor Tom Jacob, seconded by Councillor Jerry Lodge, the Members unanimously agreed to the seeking of Overdraft Accommodation in the sum of ${\it \le}6,000,000$ for the half year ended 31st December 2006.

73. PROGRESS REPORT IN RELATION TO THE ACTIVITIES OF THE COUNTY DEVELOPMENT BOARD.

The Members welcomed the report which had been prepared by Mr Declan Byrne, Director of Services. In the report reference was made to the 2005 Review of the County Development Board's ten year strategy "Realising our Potential" 2002-2012. The Review sets out priorities under each of the six strategic themes, together with actions to be taken in addressing these priorities. The Board has also reorganised its implementation structures. As a result of this all actions now come under the remit of one of the substructures or Task Groups that have been established by the Board.

Substructures - Social Inclusion Measures Working Group (SIM)

- Laois Community Forum
- Laois Rural Regeneration Partnership.

Task Groups:

- Economic Development Task Group
- Safe Environment Task Group
- Training and Education Task Group
- Children and Young Persons Task Group
- Sustainability Task Group
- Quality of Life Task Group
- Older Persons Task Group
- Transportation Task Group

The Director of Services, stressed the potential of the CDB process in the overall development of the county and acknowledged the support and Participation of the County Manager, Directors of Services, and the members of the Strategic Policy Committees. On the proposal of Councillor Mary Sweeney, seconded by Councillor Brian Stanley, the Members unanimously agreed to nominate a Member from each Electoral Area to the Cohesion Committee. Mr Peter Carey, County Manager, complimented everyone involved in the process to date and highlighted the need for an integrated approach in order to ensure the successful delivery of services at local level.

74. TAKING IN CHARGE OF ESKER GATE, MOUNTMELLICK, CO. LAOIS.

On the proposition of Councillor Michael Moloney, seconded by Councillor David Goodwin, the Members unanimously agreed to the Taking in Charge of Esker Gate, Mountmellick, Co. Laois.

75. LOCAL IMPROVEMENTS SCHEMES 2006.

The Members were circulated with draft proposals for the carrying out of Local Improvement Schemes in 2006. On the proposition of Councillor John Joe Fennelly, seconded by Councillor Mary Sweeney, the Members unanimously agreed to adopt the proposals for the carrying out of the Local Improvements Schemes for 2006 as circulated. Mr. Declan Byrne, Director of Services advised the Members that the "CLÁR" areas listed were selected by the Department of the Environment, Heritage and Local Government, on the basis of population decline over a specific period.

76. WATER SERVICES PRICING POLICY

The Members were circulated with a Progress Report on the Implementation of the Water Services Pricing Policy. Mr John Daly, Director of Services briefed the Members on the various aspects of the report. A discussion followed that dealt with many areas and concerns that Members had including:

Recovery of Capital Costs from the Non-Domestic Sector.
Information on Services.
Operational Costs.
Non-Domestic Metering.
Water Conservation.
Consultation Process.
Budget 2007.

The concerns that Members raised were noted. Clarifications were given by Mr. John Daly and the County Manager. Mr Peter Carey, County Manager in his reply referred to the Water Framework Directive, and stressed the need to manage water resources in an integrated and sustainable manner.

77. CORRESPONDENCE

Mr. Gerry Gillen, Senior Executive Officer, Corporate Affairs, indicated that that there were no items of correspondence for consideration.

78. NOTICE OF MOTIONS:

Notice of Motion No: 18/06 - Councillor Michael Moloney

"That Laois County Council call on the Health Service Executive to use a more humane and personal approach in their inspections of small enterprises"

The motion was seconded by Councillor John Moran. It was agreed that a letter should be issued to the HSE that would outline the background in relation to this matter.

Notice of Motion No: 19/06 - Councillor Michael Moloney

"That Laois County Council request the Department of Environment, Heritage and Local Government, as a matter of urgency, to make arrangements to incorporate a claw back provision as an integral Part of the awarding of Disabled Persons Grants which can be activated if deemed necessary by local authorities".

The motion was seconded by Councillor Tom Jacob. Following a full discussion the Members agreed that this Notice of Motion should be referred to the Housing SPC for their consideration. Councillor Michael Moloney agreed that this might be a better way in which to address the serious concerns that he had in relation to a small number of cases where grant assistance had been provided to improve homes that were subsequently sold.

Notice of Motion No: 20/06 - Councillor Jerry Lodge

"That this Council now ensures that all appropriate construction projects draw down the Government's % for Art as a matter of policy".

The motion was seconded by Councillor Brian Stanley. The Members were advised that the Council is already ensuring that all funding that can be availed of is drawn down. On a related matter Mr Declan Byrne advised the Members that Laois County Council have had an input into the decision making process relating to how the % for Art has been spent on N.R.A. Projects.

Notice of Motion No: 21/06 - Councillor Jerry Lodge

"That this Council reviews the designation allocated to County roads insofar as the sight distances required for planning permission on such roads are practically unattainable".

The motion was seconded by Councillor Brendan Phelan. Councillor Jerry Lodge expressed concern that current sight distances were being determined by the Speed Limits that apply in particular areas. Mr Peter Carey, County Manager, suggested that the Speed Limit Review might provide an opportunity to address the concerns that Councillor Lodge had highlighted. It was agreed that this matter would be revisited following the Review of the Speed Limits.

Notice of Motion No: 22/06 - Councillor Mary Sweeney

"That this Council adopt a policy whereby all relevant infrastructural aspects of a proposed planning application are fully investigated and discussed at pre-planning meetings".

The notice of motion was seconded by Councillor Tom Jacob. Mr Martin Daly, Acting Director of Services, advised the Members of the procedures currently in place in the Planning Department relating to the holding of Pre-Planning Meetings. Mr. Peter Carey, County Manager referred to the appeals system which is available to clients. He also advised the Members that a review will be undertaken which will include a review of the procedures that relate to the holding of Pre-Planning Meetings and the staffing structures in the Planning Department.

Notice of Motion No 23/06 - Councillor Michael Moloney

"That the Elected Members of Laois County Council write to President Fox of Mexico outlining that as Public Representatives we are extremely concerned that justice is being denied to the families of the many hundreds of girls who have been tortured and murdered in the city of Chihuahua, with no effort being made by the authorities to bring the perpetrators to justice. With heartfelt sympathy for these people we call on the President and his Government to have these heinous murders investigated".

The motion was seconded by Councillor Jerry Lodge. The Members agreed unanimously agreed that a letter should be issued to the President of Mexico. It was further agreed that a copy of the Notion of Motion should be forwarded to The General Council of County Councils and the Department of Foreign Affairs and that a letter should be issued to the Mexican Ambassador in Ireland.

Notice of Motion No 24/06 - Councillor Michael Lalor

"That this Council contact Bus Éireann to request them to erect a bus stop outside O'Moore Park in Portlaoise in order to facilitate their customers who wish to attend matches there"

The motion was seconded by Councillor Jerry Lodge. It was agreed that a letter should be issued to Bus Éireann setting out the concerns that had been expressed by the Members at the Meeting.
