77. NOTICE OF MOTIONS

Notice of Motion No: 32/2012

Councillor John Moran proposed the following Notice of Motion:-

"That on behalf of the Housing & Social SPC, it is proposed that Laois County Council put in place a facility whereby a borrower in difficulties with his/her mortgage would be allowed to recalibrate their loan, thereby extending the period for a further 5 years to facilitate a lower repayment"

This motion was seconded by Councillor Catherine Fitzgerald.

The Members were advised that borrowers, who are experiencing financial difficulties are dealt with on an individual basis by the Council and every effort is made to assist them in meeting their loan commitment. These include arrears arrangements and/or changes to either the term or type of loan.

Changes to the term of a housing loan are governed by Housing (Local Authority Loans) Regulations, 2009 (SI No. 145/2009) which include the following conditions:-

The amount of a loan shall not exceed €220,000 A loan shall be repaid within such period not exceeding 30 years

In addition, in order for borrowers to maintain mortgage protection insurance cover in the event of death and disability, loans must be repaid before the borrowers reach the age of 65.

As a result, it is not always possible to extend the existing loan term.

Notice of Motion No: 33/2012

Councillor John Moran proposed the following Notice of Motion:-

"That on behalf of the Housing & Social SPC, it is proposed that Laois County Council write to the Department of the Environment, Community & Local Government to seek funding to purchase houses which are being re-possessed by Laois County Council"

This motion was seconded by Councillor Catherine Fitzgerald. It was agreed that a letter issue to the Department of the Environment, Community & Local Government in this regard.

Notice of Motion No: 34/2012

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council call on the Minister for Communications, Energy & natural Resources, Mr. Pat Rabbitte to bring in legislation to ensure that Mobile Phone/Internet Providers are more responsible and accountable to their customers"

This motion was seconded by Councillor Mary Sweeney. It was agreed that a letter issue to the Minister for Communications, Energy & Natural Resources in this regard.

The Members also expressed concern with regard to door to door selling of these products and the after sales service provided and it was agreed that this would also be included in the correspondence to the Minister.

Notice of Motion No: 35/2012

Councillor Mary Sweeney proposed the following Notice of Motion:-

"That Laois County Council inform all prospective 3rd level grant applicants of new arrangements for centralized applications and encourage them to apply early. Existing applicants also should be advised that they will continue to process their applications with Laois County Council"

This motion was seconded by Councillor Catherine Fitzgerald.

The Members were informed that the City of Dublin VEC have advised that they have been in contact with all Career Guidance Teachers with a view to informing all prospective third level applicants of new arrangements for centralized applications and encouraging them to apply early. Renewal forms have issued to all existing students and they have been advised to return completed forms to Laois County Council. Information with regard to the new arrangement for 2012/2013 has been placed on laois.ie with the required link to studentfinance.ie.

Notice of Motion No: 36/2012

Councillor John Joe Fennelly & Councillor Brendan Phelan proposed the following Notice of Motion:-

"That Laois County Council request Bus Eireann to retain their full bus service and bus stops throughout County Laois"

This motion was seconded by Councillor Mary Sweeney. The Members expressed serious concern in relation to the proposal to remove bus stops from various towns around the County. It was agreed that an urgent letter issue to Bus Eireann in this regard
