34. FILLING OF CASUAL VACANCY ON LAOIS COUNTY COUNCIL

Notice of Motion No: 11/2013

Councillors Padraig Fleming, Catherine Fitzgerald, Brendan Phelan, John Joe Fennelly, Jerry Lodge, Ray Cribbin, Seamus McDonald & Patrick Bracken proposed the following Notice of Motion:-

"That Laois County Council amend the County Development Plan in relation to Wind Energy Strategy so that wind turbines shall be located further away from dwelling houses in view of new technology and the increased height of wind turbines"

This motion was seconded by Councillor Fitzgerald

The Members were advised that the policy of Laois County Council is set out in the Wind Energy Strategy for County Laois adopted as part of the Laois County Development Plan 2011 – 2017. The overall objective of the strategy is to facilitate the development of wind energy in the County in ways that balance the environmental, social and economic benefits with any demonstrated impacts particularly those of a landscape and amenity variety.

The strategy evaluates and analyses the potential wind energy resource within County Laois, outlines the key environmental and planning considerations for windfarm development forms the basis for a more streamlined assessment of planning applications for wind farming and ultimately assists in the decision making process of the Planning Authority.

The strategy makes numerous references to the 'Wind Energy Development Guidelines' prepared by the Department of the Environment in 2006. This is the official Department guidance in relation to the industry.

The Department has just announced a comprehensive review of the guidelines in conjunction with the Department of Communications, Energy and Natural Resources. It is envisaged that this review will be completed by the end of the year. The Planning Authority will also undertake a review of the Wind Energy Strategy as part of its mid-term review of the Laois County Development Plan 2011-2017. This review is also scheduled to commence before the end of the year.

It is considered, therefore, that any such amendment as proposed in the Notice of Motion is premature. Following a discussion, it was agreed that a letter would issue to the Minister outlining the Members concerns.

Notice of Motion No: 07/2013

Councillor Alan Hand proposed the following Notice of Motion:-

"That this Local Authority re-double its efforts in the collection of monies owed in respect of derelict sites and that this Council write to the relevant Minister calling for stronger legislation to deal with derelict sites"

This Notice of Motion was seconded by Councillor Lisa Delaney

The Members were informed that a comprehensive review of the existing Derelict Sites Register has commenced and the Council is following up with all necessary appropriate action. It was agreed that a letter issue to the Minister in this regard.

"That Laois County Council supports frontline public sector workers both in the Health Services and the Gardaí who are required to work weekends in the public interest and that they should not be singled out for a disproportionate pay cut because they provide essential and emergency services at weekends"

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council request the Minister for the Environment, Community & Local Government, Mr. Phil Hogan, T.D., to introduce legislation which will change the present waste system of paying per bin to paying by weight"

This motion was seconded by Councillor Alan Hand. It was agreed that a letter issue to the Minister in the regard

Notice of Motion No: 10/2013

Councillor Catherine Fitzgerald proposed the following Notice Of Motion:-

"That this Council request the Minister for the Environment, Community & Local Government, Mr. Phil Hogan, T.D., to introduce legislation that could provide for the removal of unruly and unsociable tenants from their private rented accommodation"
