"That Laois County Council provide funding to ensure that all of the towns and villages of Laois have Public Playground facilities"

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised that Laois County Council will continue to assist local communities to identify suitable locations & to source funding for community playgrounds as has been done over the past 12 years. Currently no funding is available to Laois County Council to directly fund playground developments.

Notice of Motion No: 32/2015

Councillor Jerry Lodge proposed the following Notice of Motion

"That this Council agrees to review it's current litter management plan as the incidence of dumping in the countryside throughout County Laois has now become an epidemic"

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. The Members were advised that the new Litter Management Plan 2015-2017 is currently being drafted. It will be presented to the Transportation, Environment & Emergency Services SPC meeting on 11 June 2015 and will then go out for a 4 week public consultation phase. Submissions received following the public consultation will be considered and the necessary amendments will be made to the Draft Litter Management Plan prior to bringing it before the SPC meeting scheduled for September 2015. Once approved at this SPC meeting, it will move for formal adoption through CPG and Full Council Meetings during Quarter 4 of 2015.

The Litter Management Section continues to deal with illegal dumping on a daily basis and some of the actions for 2015 to date include:

- 4 No. Section 55 Notices under the Waste Management Act issued in relation to larger scale illegal dumping
- Litter Fines
 - o 88 No. Litter Fines issued to date
 - o 41 No. litter fines paid
 - o 8 prosecutions taken
 - o 2 convictions secured
- CCTV utilised successfully at Bring Banks during Q4 2014 & Q1 2015 63 fines issued
- Specific Area Clean-ups carried out at various locations in 2015, some of these include
 - o Bay Road, Mountmellick (2 clean ups)
 - o Ashgrove, Mountmellick,

- Brockera
- o Ballyfin
- o Straboe
- Representatives of Downtown Portlaoise & Portlaoise Tidy Towns carried out a major clean up of the area adjacent to Hynds Square and removal of waste was provided by the Cleansing Team and the local Litter Warden
- Individual litter black spots have been cleaned between Portlaoise and Mountmellick on the N8o and a tender is being issued this week (week commencing 27th April 2015) for a complete litter pick of N8o within the County Boundaries.
- Almost 80 groups and committees around the county registered for clean up Laois week 2015"

Notice of Motion No: 33/2015

Councillor Noel Tuohy proposed the following Notice of Motion:

"That this Council call on Dunnes Stores to enter into meaningful talks with the Mandate Trade Union"

Notice of Motion No: 36/2015

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council inform Members as to:

- (i) How many plots of land are in the Land Aggregation Scheme
- (ii) How much are these lands costing Laois County Council
- (iii) How much are the units at Conniberry Way costing including the site cost

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised of the following:-

- There are 10 plots of land in the Land Aggregation Scheme. The lands are situated in Portlaoise, Doonane, Rathdowney, Durrow, Ballinakill, Mountrath & Castletown
- There is no cost to Laois County Council as 5 plots of land had their loans redeemed in full by the Department and 5 currently have principal and interest recouped by the Department.
- The preliminary budget cost approval for Conniberry Way (33 units) is €4,774,230. The final cost will not be known until the scheme has gone to tender later this year.

It was further agreed to forward details of the land costs to Councillor Fitzgerald.

Notice of Motion No: 37/2015

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council hold a special meeting to address speed limits on roads and estates in the County"

This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were advised as follows:

Policy guidance has recently been received from the Department of Transport, Tourism and Sport in relation to the setting of speed limits. Further correspondence has issued within the last week in relation to funding requirements for new signage in 2015 and beyond.

Road Design now has a detailed inventory of all sign locations in the county on our road GIS database. The Speed Limit Review was discussed at the Transportation Strategic Policy Committee meeting before Easter and proposals under a number of broad headings are scheduled to be brought back to the next SPC meeting in June on how roads section are intending to proceed. These will deal with signage and the criteria to be used to determine the proposed speed limit for the road in question. Following that a further committee meeting can be held with all councillors before the summer.

Notice of Motion No: 38/2015

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council request the Government to bring in urgent legislation re: Derelict Sites/Dangerous Sites/Vacant Houses"

The Members were advised that in dealing with Derelict Sites and Dangerous Structures, Laois County Council operates within the confines of existing legislation, namely Derelict Sites Act 1990 and the Local Government (**Sanitary Services**) Act, 1964. The Derelict Sites (Amendment) Bill 2015 is at draft stage and may, if adopted into law, provide for the tightening of regulations in relation to derelict sites.

Notice of Motion No: 39/2015

Councillor Caroline Dwane Stanley proposed the following Notice of Motion:-

"To ask Laois County Council for an up-date on progress on their commitment to provide a private meeting room for members of the public to meet staff at County Hall. This commitment was given in answer to my Motion on this issue in 2014"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that Laois County Council expect to be in a position to have this facility in place in approximately 2 months – details are currently being finalised.

"That Laois County Council contacts the Minister for the Environment, Community & Local Government to find out when funding will be approved and provided for Housing Grants for the elderly and for people with disabilities"
