4. REPORTS ON AREA MEETINGS & S.P.C. MEETINGS HELD IN DECEMBER 2010

On the proposition of Councillor Ray Cribbin, the Members noted the reports as circulated on the Area Meetings & S.P.C. Meetings held in December 2010.

5. PART VIII OF THE PLANNING & DEVELOPMENT REGULATIONS, 2001 – CLONASLEE INTEGRATED CONSTRUCTED WETLAND SCHEME

The Members were circulated with a copy of the planning report in relation to the above proposed development. The Members were advised that Laois County Council proposes to construct an Integrated Constructed Wetland (ICW) at Clonaslee. The objective of the scheme is to provide improved wastewater infrastructure in the village. This will improve the water quality of the Clodiagh River and provide capacity for future development of the town which aligns with the strategic aims of the Clonaslee Area Plan. The proposed ICW will be constructed on a 6.23 hectares Greenfield site immediately adjacent to the existing wastewater treatment works. The proposed works consist of the following elements:

- Inlet Pumping Station
- 2 No. Initial Receiving Ponds
- 5 No. Treatment Ponds
- Pumping Station Control building with Telemetry and a SCADA system
- Site security fencing, site lighting

- Site access road
- Boundary screen planting and landscaping.

On the proposition of Councillor David Goodwin seconded by Councillor Seamus McDonald, the Members unanimously agreed to the proposed development in accordance with Part VIII of the Planning & Development Regulations, 2001.

6. PART VIII OF THE PLANNING & DEVELOPMENT REGULATIONS, 2001 – PORTLAOISE & MOUNTMELLICK WATER SUPPLY IMPROVEMENT SCHEME, PROPOSED RAW WATER STORAGE/BLENDING TANK AND PUMPING STATION AT STRABOE

The Members were circulated with a copy of the planning report in relation to the above proposed development. The Members were advised that the Portlaoise and Mountmellick WSIS is currently served by a combination of surface water and groundwater sources. The existing demands for the scheme are estimated at approximately 10,500m3/d. The works associated with the proposed development include the following elements:

- Construction of a new 2,000m3 capacity raw water storage/blending tank
- Construction of a new pumping station and control building
- Demolition of existing pumphouse
- Associated site works

On the proposition of Councillor Brian Stanley seconded by Councillor Mary Sweeney, the Members unanimously agreed to the proposed development in accordance with Part VIII of the Planning & Development Regulations, 2001.

8. (i) TAKING IN CHARGE OF CORRIG LODGE, PORTARLINGTON

On the proposition of Councillor Paul Mitchell seconded by Councillor Ray Cribbin, the members unanimously agreed to the taking in charge of Corrig Lodge, Portarlington.

(ii) TAKING IN CHARGE OF KILTEALE AVENUE, DUBLIN ROAD, PORTLAOISE

On the proposition of Councillor Mary Sweeney seconded by Councillor Brian Stanley, the members unanimously agreed to the taking in charge of Kilteale Avenue, Dublin Road, Portlaoise.

9. UPDATE ON THE IMPLEMENTATION OF THE CORPORATE PLAN 2009 – 2014

The Members were circulated with a copy of the Corporate Plan 2009 – 2014. The County Manager, Mr. Peter Carey briefed the Members on the plan. This Corporate Plan provides the framework for the implementation of a coherent strategy for the development of our County for the period 2009 – 2014 and was prepared following consultation with employees, elected representatives, community, voluntary and environmental interests, external stakeholders and other public bodies operating at local level. The County Manager indicated the difficulties in maintaining the level of services with the reduction in staff numbers. He acknowledged the role of all the staff of Laois County Council and in particular during the recent prolonged severe weather and thanked staff for doing an excellent job in difficult circumstances. These sentiments were endorsed by the Members.

10. UPDATE ON KYLETELISHA LANDFILL

The Cathaoirleach, Councillor James Deegan welcomed Members of the Kyletelisha Landfill Monitoring Committee to the Chamber. The County Manager, Mr. Peter Carey complimented Mr. John Daly, Director of Services, Mr. John O' Donoghue, Senior Engineer and his staff on an excellent report on the Landfill. The County Manager informed Members that Laois County Council had carried out a marketing exercise in relation to the sale of the facility and will not be disposing of the landfill and it is intended to proceed with the development of a further cell with a capacity of approximately 120,000 tonnes. When this cell has been filled in 2015/2016, the landfill will be closed unless there is a substantial change in market conditions/Government policy in the meantime. The Members were also informed that there have been substantial changes in relation to the requirements on Laois County

Council for the operation of the landfill and that the legal licence is very complex. The County Manager, Mr. Peter Carey acknowledged the staff at the landfill for the efficient running of the facility, for their level of commitment and for the efficiencies achieved. The Members also complimented the officials on the report.

11. SUSPENSION OF STANDING ORDERS

As the time had reached 1.00 p.m., on the proposition of Councillor William Aird seconded by Councillor James Daly, the members unanimously agreed to suspend Standing Orders to continue with the meeting.

12. ST. ABBAN'S ATHLETIC CLUB – RECOGNITION OF ACHIEVEMENT

The Cathaoirleach welcomed athletes and committee members from St. Abban's Athletic Club to the Council Chamber and congratulated the club for recently achieving the All-Ireland Club of the Year. The Members congratulated the Club on their wonderful achievement. The County Manager, Mr. Peter Carey also extended his congratulations to the Club and complimented them on the quality of their facility at St. Abban's and wished them every success into the future. On behalf of the club, Mr. Brian Kelly thanked Laois County Council for the honour.

14. ANY OTHER BUSINESS

Councillor John Joe Fennelly requested an update on Donaghmore Museum. The County Manager, Mr. Peter Carey advised that certain works are required

to the bell tower and existing buildings. This work has been costed and a funding application to Laois Partnership in the sum of €500k prepared. The Council will be spending €65k approx in support funding over the next three years on these securing works. The Part VIII process will also be commencing. The Museum Committee will lodge, with our assistance, the application to Laois Partnership. A report will issue to update Members in due course.

The County Manager, Mr. Peter Carey also informed the Members regarding the Mountain Bike Project in association with Offaly County Council and Coillte and advised that Coillte have now signed off on the project. The Cathaoirleach advised that Montebelluna, Italy are staging the World Mountain Bike Championships in June 2011 and have invited representatives from Council to attend. There is the possibility of a co-operative approach to enable Laois County Council to run the event in 2012/2013. The Members welcomed this development.

15. NOTICE OF MOTIONS

Notice of Motion No: 01/11

Councillor Brian Stanley proposed the following Notice of Motion:-

"That this Council clarify the requirements regarding the depth for water pipes to be laid in new developments and ensure that prior to estates being taken in charge that mains and service pipes are installed properly"

This motion was seconded by Councillor Rotimi Adebari. The Members were advised that the National standard set by the Department of the Environment is contained in 'Recommendations for Site Development Works' 1998. Water mains should be laid so as to have a minimum of 900 millimetres cover and water service pipes laid with 600 millimetres cover and stop cocks laid at 300mm cover. The Building Control Officer, Area Engineer and other sections of the Council ensure compliance with the standards before an estate is taken in charge.

Notice of Motion No: 02/11

Councillor Martin Phelan proposed the following Notice of Motion:-

"That this Council calls on the Government to make capital available to industries and businesses now that we own the banks"

This motion was seconded by Councillor John Moran. It was agreed that a letter issue in this regard.

Notice of Motion No: 03/11

Councillor Martin Phelan proposed the following Notice of Motion:-

"That this Council call on the N.R.A. to finish outstanding minor works on the M7/M8"

This motion was seconded by Councillor John Joe Fennelly. The Members were advised that Laois County Council has met the local Councillors and compiled a list of outstanding issues and submitted these to the N.R.A. The Contractor is working through these outstanding issues. The recent spell of bad weather has impacted slightly on the timeframe.

"That this Council retain all outdoor staff to repair all roads which have been destroyed by frost and snow"

This motion was seconded by Councillor Michael Lalor. The Members were advised that the Council will continue to deploy all available staff resources to the repair of damaged roads, subject to the budgetary restrictions which apply.

16. ANY OTHER BUSINESS

Ms. Anna Marie Delaney, Director of Services indicated that the Register of Electors for 2011/2012 becomes live on the 15th of February 2011. Laois County Council are awaiting the official closing date for the Supplement to the Register from the D.O.E.H.L.G.

The Cathaoirleach, Mr. James Deegan wished all the candidates in the forthcoming general election well in their endeavours, in particular the Members of Laois County Council, Councillors Rotimi Adebari, John Moran & Brian Stanley.
