109. PART VIII OF THE LOCAL GOVERNMENT PLANNING & DEVELOPMENT REGULATIONS, 2001 IN RESPECT OF PROPOSED SCHEME AT THE DOWNS, PORTLAOISE FOR THE PROVISION OF A NEW PURPOSE BUILT SCHOOLS CAMPUS COMPRISING 3 NO. PRIMARY SCHOOLS AND ANCILLARY INFRASTRUCTURE.

The Members were circulated with the planning report on the above proposed development. In accordance with the provisions of Part V111 of the Planning & Development Regulations, 2001 as amended, Laois County Council, in partnership with the Minister for Education & Skills, seeks consent for the development of a purpose built primary schools campus and ancillary facilities on an extensive 3.93 hectares (9.7 acres) at Downs, Portlaoise, Co. Laois. In particular, the proposed scheme for the following:-

- Construction of a new 2-storey, 16 classroom Portlaoise Educate Together National School of 2,600 square metres floor area
- Construction of a new 2-storey, 16 classroom Gaelscoil Portlaoise National School of 2,600 square metres floor area
- Construction of a new single storey, 4 classroom Maryborough National School of 820 square metres floor area
- Provision of ancillary infrastructure including ball courts, play areas, storage areas, bicycle
 racks, pedestrian and cycle paths, car parking, foul and surface water drainage, portable
 water connection, internal road
- Installation of palisade security fencing around the curtilage of the site and
- Landscaping of the site

The proposed school campus will effectively replace three existing schools in the town, namely: Portlaoise Educate Together National School (currently located in former VEC premises on Railway Street), Gaelscoil Portlaoise National School (currently located off the Mountrath Road) and Maryborough National School (currently located on Stradbally Road). The Members enquired as to

the provision of cycle lanes and drop off areas at the schools. Mr. Kieran Kehoe, Director of Services confirmed that an application for funding has been made under the Active Town Travel Scheme and there is also a Mobility Action Plan in place.

On the proposition of Councillor William Aird seconded by Councillor Alan Hand, the Members unanimously agreed to proceed with the proposed Part VIII of the Local Government Planning & Development Regulations, 2001 in respect of proposed scheme at The Downs, Portlaoise for the provision of a new purpose built School Campus comprising 3 no. Primary Schools and ancillary infrastructure.

(I) LEASE OF 0.3552 HECTARES OF LAND AT DOONANE IN THE TOWNLAND OF DOONANE FOR A PERIOD OF 10 YEARS TO DOONANE RESIDENTS ASSOCIATION AND ST. ABBAN'S COMMUNITY ASSOCIATION, FOR A CONSIDERATION OF €100.00 PER ANNUM

On the proposition of Councillor Padraig Fleming seconded by Councillor James Daly, the Members unanimously agreed to the lease of 0.3552 hectares of land at Doonane in the townland of Doonane for a period of 10 years to Doonane Residents Association and St. Abban's Community Association, for a consideration of €100.00 per annum

112. NOMINATION OF MEMBER TO THE BOARD OF LAOIS COMMUNITY & ENTERPRISE DEVELOPMENT COMPANY LTD T/A LAOIS PARTNERSHIP COMPANY

The Members were advised that Laois County Council were advised that in Laois Partnership Companys' Memorandum & Articles of Association at each A.G.M., one third of the Directors shall retire from office, those Directors to retire every year to be those who have served the longest in office sine the last election. As Councillor Tom Mulhall is one of the longest serving Directors, he is nominated for retirement.

On the proposition of Councillor John King seconded by Councillor Martin Phelan, it was unanimously agreed that Mr. Tom Mulhall, M.C.C., be re-nominated to the Board of Laois Community & Enterprise Development Company t/a Laois Partnership Company.

Mr. Gerry Murphy, Head of Finance briefed the Members on the contents of the report which is delivered in accordance with Section 120 of the Local Government Act, 2001. The main issues highlighted in the report are as follows:

- Development Levies

The Head of Finance, Mr. Gerry Murphy responded to the various concerns of the Members.

114. TAKING IN CHARGE OF GRALLOW WOOD, ABBEYLEIX

The Members were advised that an advertisement was placed in the Leinster Express on the 18th of July 2012 giving notice of intention to consider the making of a declaration regarding the taking in charge of 'Grallow Wood', Abbeyleix, Co. Laois. The closing date for submissions was 12.00 p.m. on Friday, August 31st 2012. No submissions were received. It is estimated that the cost to Laois County Council will be as follows:-

- Public Lighting approx €690.00 per annum
- Ongoing maintenance and repair of roads and services none envisaged for next 15 years
- Annual maintenance and running costs of pumping station €1,500.00

On the proposition of Councillor Martin Phelan seconded by Councillor John Joe Fennelly, the Members unanimously agreed to the taking in charge of Grallow Wood, Abbeyleix, Co. Laois.
