129. UPDATE BY MR. PAUL VEALE, MIDLANDS REGIONAL BUSINESS DEVELOPMENT MANAGER, I.D.A. IRELAND

The following Notice of Motion No: 63/2015 proposed by Councillor Jerry Lodge was also discussed as part of the presentations given by IDA:-

"That this meeting be presented with a report on the number of meetings between Laois County Council and IDA personnel in 2014 and up to the end of June 2015 and this report to include the number of foreign companies brought to Laois by I.D.A.

This Notice of Motion was seconded by Councillor James Kelly.

Mr. Paul Veale, I.D.A. Ireland delivered a presentation to the Members. He briefed Members on the area of foreign direct investment, its impact in Ireland, the main growth areas and also IDA's targets for 2015 – 2019. Mr. Veale referred to the Midlands Action Plan for Jobs and its objectives. The Members expressed dissatisfaction with the number of visits by the I.D.A. to Laois in the last four years. Councillor Jerry Lodge proposed that a delegation meet with the new CEO of the IDA, Mr. Martin Shanahan to outline why Laois had been neglected in recent times.

130. UPDATE BY MR. DENIS DUGGAN, SENIOR REGIONAL DEVELOPMENT EXECUTIVE, EASTERN & MILDAND REGION, ENTERPRISE IRELAND & MR. MICHAEL BROUGHAM, DIRECTOR, EASTERN & MIDLANDS REGION, ENTERPRISE CENTRE

Mr. Denis Duggan, Senior Regional Development Executive, Eastern & Midland Region, Enterprise Ireland delivered a presentation to the Members. Mr. Duggan detailed the client base of Enterprise Ireland and also detailed ways in which their client companies are supported. He gave details on the start-ups for 2014 and also referred to their engagement with the Local Enterprise Offices. The Members expressed their thanks to Mr. Duggan and complimented the Local Enterprise Office on it's work with start-up enterprises.

131. MONTHLY MANAGEMENT REPORT FOR SEPTEMBER 2015 (IN ACCORDANCE WITH CIRCULAR LETTER LG 18/2014)

Mr. John Mulholland, Chief Executive briefed the meeting on this matter and the report for September was circulated. The report for September was unanimously agreed and noted. A number of queries were raised on the report and the Directors of Services responded to the queries raised.

132.DRAFT LITTER MANAGEMENT PLAN 2015 – 2017

The Members were circulated with a copy of the draft Litter Management Plan. Mr. Kieran Kehoe, Director of Services responded to the various queries raised and briefed Members on the key performance indicators and the various grants available.

On the proposition of Councillor John Joe Fennelly seconded by John King, the Members unanimously agreed to adopt the Litter Management Plan 2015-2017.

The Members paid compliments to the Director of Services, Mr. Kieran Kehoe and the staff in the Environment Section & also the Tidy Towns Groups for their committment. Mr. Kieran Kehoe, Director of Services thanked all the Environment Staff, Litter Wardens, Outdoor Staff, Gateway Staff & thanked the Members for their support.

133. DRAFT SCHEME OF POLLING DISTRICTTS AND POLLING PLACES

The Members were circulated with a copy of the draft Polling Scheme for County Laois. It was noted that the making of a Polling Scheme is now a devolved function of the Council under Section 12 of the Electoral (Amendment) Act, 2001. It was noted that a public notice will be placed in the local newspapers advising that the scheme is available for inspection and that representations in relation to the draft scheme may be made within 5 weeks from the publication of the notice. After the five weeks have expired, the Council will consider any proposals for alterations or representations and may then make the Polling Scheme in accordance with the Draft scheme or with amendments. It was also noted that the County Registrar was consulted in relation to the proposed scheme.

On the proposition of Councillor John Joe Fennelly seconded by Councillor John King, the Members unanimously agreed to the draft scheme of Polling Districts and Polling Places as circulated.

137. CAR PARKING POLICY FOR DECEMBER/CHRISTMAS 2015

The Members were circulated with proposals for car parking for December/Christmas 2015 which has been recommended and adopted by the Roads, Transportation, Environment, Fire Services & Rural Water S.P.C.

The Members noted the following proposals:

- First Hour Free parking to apply from 1st of December to the 19th of December 2015
- Free parking to apply from Monday, 21st of December 2015 to Saturday, 2nd January 2016
- The underground car park at the Civic Plaza will be opened up and employees of the Portlaoise Traders can use it free

A lengthy discussion ensued during which Members suggested various other options and that the policy be extended. It was agreed that the matter would revert back to the SPC for agreement.
