#### INTRODUCTION

Ms. Angela McEvoy, Senior Planner informed the Members of their role in this process as Elected Members as follows:-

Deciding whether to adopt or to propose amendments to the Draft Local Area Plan is a function reserved for the Elected Members of Laois County Council. On foot of the submissions received and on review of the content of the Draft Graiguecullen Local Area Plan 2012-2018, prepared as part of a Joint Spatial Plan for the Greater Carlow Graiguecullen Urban Area with Carlow Town Council and Carlow County Council, the Manager has recommended a number of material alterations to the Draft. If the Members decide that these, or other material alterations should be made to the Draft Plan, the proposed amendments must go on public display for a period of four weeks Ms. Gormla O'Corrain, Executive Planner outlined progress to date. She described the structure and principal elements of the Draft Graiguecullen Local Area Plan 2012 – 2018 and indicated that Draft Plan was on public display from the 16<sup>th</sup> of March 2012 until the 27<sup>th</sup> of <u>April</u> 2012, along with Draft Environmental Report, Appropriate Assessment and Flood Risk Assessment. Public Meetings were held in Graiguecullen Parish Centre on March 28<sup>th</sup> and April 11<sup>th</sup> 2012. The Managers report was then prepared. During the public consultation period 121 submissions were received. Some petitions bring participation number to 199.
