SICAP

(a) SICAP 2017-End of Year (approval by LCDC of End of Year report)

It was advised that the SICAP sub-committee had reviewed the end of year report for 2017. Copies of End of Year progress report had been submitted to Members & copies of End of Year Financial position were circulated at the meeting. The committee were advised that Pobal were carrying out a parallel review and the results were awaited and subject to minor amendment if required by Pobal.

John Mulholland proposed approval of the SICAP 2017 End of Year financial report seconded by Cllr Pascal McEvoy. Ms. Ann Goodwin mentioned the difficulty with recording VAT on the iris system. Mr. Mulholland stated that as the dissatisfaction should be noted and the LCDC as financial partner should contact Pobal.

(b) 2018 Annual Plan

It was advised that the new SICAP programme commenced in January. Retrospective approval was sought for the advance payment to Laois Partnership Company in the amount of €146,656 for the implementation of the SICAP plan for January-March 2018. Approval to the payment was proposed by Clir. John King and Seconded by Evelyn Reddin. Anne Goodwin briefed the members on recent staff changes in the SICAP department. The members of the LCDC wished all of the new staff the best of luck in their new roles.

Healthy Ireland Fund

An update was provided to the members on the Healthy Ireland Fund. One tender was received for the preparation of the Healthy Ireland Strategy which was evaluated prior to the meeting by the Chairperson & Mary Delaney, H.S.E. & recommended acceptance of this tender. This was proposed by Cllr. Pascal McEvoy and approved by Cllr. John King. The following agreed to form part of the Healthy Ireland sub-committee; Mary Delaney HSE, Paddy Buggy PPN, Evelyn Reddin LEO and Cllr. Pascal McEvoy

LECP Monitoring 2018

It is the role of the LCDC to monitor the LECP. Information is being gathered on all of the actions in the LECP for 2017 at present. An implementation plan for 2018 will be presented for consideration by the Members at the next meeting.

- Laois County Council has advertised for a temporary Research Officer and one of the roles will be to work on the LECP in conjunction with the planning Department to work on a strategic plan.
- Tourism strategy will be launched on 1st February in Durrow Castle
