DHPCLG Community Facilities Scheme 2017

Mr. Michael Rainey advised the members that a general call for applications in respect of this scheme was recently advertised and in that regard, two applications recently received. He reminded the members that the closing date nationally for applications would be 30th June 2017.

It was agreed that forms would be made available to members should they wish to circulate same to groups. The members noted that forms and application guidelines would be available also on the Council and PPN websites.

CLÁR 2017

Mr. Michael Rainey outlined the details of the CLÁR scheme for members, in particular the LCDC role in approval of CLÁR Measure 3 funding. He circulated the applications received (copy attached) and sought the members' approval in principle and recommendation to present the applications to the local authority for submission to the Dept He explained that as per the scheme, a maximum of 20 applications can be submitted by each local authority across 4 Measures.

Upon the proposal of Ms. Anne Goodwin and seconded by Mr. Michael Bergin it was agreed that all CLÁR Measure 3 applications presented should be approved in principle and recommended to Laois County Council for submission to the DHPCLG for approval.

LECP Annual Implementation Plan 2017

Ms. Georgina Ireland presented the draft LECP Annual Implementation Plan 2017 in respect of actions monitored by the LCDC. She outlined the procedure set out in legislation as to the Annual Implementation Plan and advised this proposed annual plan contained 79 actions for monitoring by the LCDC. The members' approval of this plan was sought and upon the proposal of Cllr. Paschal McEvoy and seconded by Cllr. John King, the LECP Annual Implementation Plan 2017 in respect of LCDC actions was approved.
