## 142. VOTE OF SYMPATHY

The vote of sympathy was endorsed by all Members present and the meeting was adjourned for a period of five minutes as a mark of respect to Mr. Ireland.

## 143. CONFIRMATION OF THE MINUTES OF THE OCTOBER MEETING OF LAOIS COUNTY COUNCIL HELD ON THE 24<sup>TH</sup> OF OCTOBER 2016

On the proposition of Councillor John Moran seconded by Councillor John King, the Minutes of the October meeting held on the 24<sup>th</sup> of October 2016 were agreed as circulated.

Councillor William Aird referred to Item No. 128 in the minutes regarding the Midlands Regional Hospital, Portlaoise.

The following Notice of Motion proposed by Councillor Noel Tuohy and seconded by Councillor Willie Aird was also discussed:

## "That the recent deferred meeting between the Councillors of Laois County Council and the Minister for Health, Mr. Simon Harris and the Minister for Foreign Affairs & Trade, Mr. Charles Flanagan be reconvened immediately'

It was noted that correspondence had been received from Minister Harris on the 8<sup>th</sup> of November 2016 indicating that the Dublin Midlands Hospital Group has recently produced a draft plan which sets out a proposed service design for a new model of clinical service delivery at Portlaoise Hospital. The draft plan has been discussed with the Department and is currently the subject of further work and consideration within the HSE with a view to finalising it for submission to the Department. The Minister indicated that he would then be briefed in advance of further necessary consultations with stakeholders, including GPs, Consultants and Councillors.

No decisions have been made in relation to Portlaoise Hospital at this stage, but once the work outlined is completed Minister Harris stated that he would be happy to meet with the Laois Oireachtas members and members of Laois County Council in the context of the consultation process.

On the proposition of Councillor Catherine Fitzgerald it was agreed that the Cathaoilreach Councillor Tom Mulhall together with Councillor Brendan Phelan, Councillor John King & Councillor John Joe Fennelly organise a meeting for the elected members of the Council with the relevant Ministers and the 3 Oireachtas Members. Councillor Caroline Dwane Stanley also proposed that a representative from the Laois GPs be asked to attend also.

Carlow to retain the continuance of the use of the existing industrial unit to facilitate a local community group as granted under Planning Ref: 09/29 at Unit 5A, Barrowside Business Park, Sleaty Road, Graiguecullen, Co. ## Notice of Motion No: 33/2016

# "That Laois County Council agree to include Clonad on its Cemetery Register"

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. The Members were advised that Clonad cemetery is not in the ownership of Laois County Council. The Council has no role in relation to this cemetery and no allowance has been made in the annual budget for same. It should be noted that there are numerous similar cemeteries in the county for which Laois County Council are not responsible. ## Notice of Motion No: 34/2016

Councillor William Aird proposed the following Notice of Motion:-

# *"That all requests received by Laois County Council for Civic Receptions be included in monthly correspondence to Councillors"*

This Notice of Motion was seconded by Councillor Noel Tuohy. The Members were advised that the Members of Laois County Council at their meeting held on 14<sup>th</sup> December, 2015 adopted Protocols for the conferral of Civic Honours and Receptions.

These Protocols provide that any Member wishing to propose a formal Civic Reception for any group or individual must consult with the Cathaoirleach of the Council who will raise the matter for discussion with the Corporate Policy Group. The CPG will consider all proposals for a Civic Reception at their meetings held in January, April, July and October of each year and recommend on the appropriate level of honour that should be conferred in any particular case and by whom, i.e. Plenary or Municipal District Level.

Recommendations for Civic Receptions at Plenary Level will be submitted to the full Council for approval at the next available monthly meeting, after consideration at CPG, while recommendations for recognition to be conferred at Municipal District level will be submitted to the relevant Municipal District for approval at their next available meeting; it was also agreed to circulate requests received in monthly correspondence.

#### Notice of Motion No: 35/2016

Councillor Willie Aird proposed the following Notice of Motion:-

# *"That Laois County Council investigate options for providing a premises to Down Syndrome Centre – Midlands"*

This Notice of Motion was seconded by Councillor Jerry Lodge. The Members were advised that The Committee of Down Syndrome Centre – Midlands have already made a presentation to officials on their aspirations for a Down Syndrome Centre in Portlaoise. The group has particular requirements for the location of the centre. While Laois County Council would not have a premises meeting the requirements of the Centre, the Council can assist the Group in their search and in their interactions with other bodies who may be able to assist.

## Notice of Motion No: 36/2016

Councillor John Joe Fennelly proposed the following Notice of Motion:

# *"That all Local Authority houses in County Laois be provided with Carbon Monoxide Alarms"*

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. The Members were advised that Carbon Monoxide Alarms have been provided to occupants of demountables and are included in the list of works to be carried out when houses are purchased and when existing dwellings are being re-let.

A survey of our existing Council stock is being carried out to identify at the outset the homes of elderly residents that may require carbon monoxide alarms. It is expected that these alarms will be installed in the coming months. Carbon Monoxide alarms will also be installed in houses when the Maintenance team call to carry out repairs. The Council will be kept advised of progress.
